We are very appreciative of the efforts of all involved in this important effort. ## MINUTES FRIENDS OF THE TEXAS ROOM OCTOBER 23, 2004

Friends of the Texas Room met October 23, 2004, at 10:00 a.m. at the Museum of Printing History, 1324 W. Clay. President Dorothy Knox Houghton called the meeting to order after which the minutes of the July 20 meeting were approved as printed in the Newsletter. The president thanked Sandra Lord and Dorothy Johnson for preparing and distributing the Newsletter. In the absence of

Treasurer Marks Hinton, the president reported that the organization currently has a bank balance of \$11,518.03. This amount includes \$2,000 received from ExxonMobil through applications submitted by two of our volunteers. Members who are eligible for acquiring similar funds were encouraged to consider applying for them. Karen Rogers, founding president of the Rice Historical Society, presented a copy of *Houston as a Setting of the Jewel* to be placed in the Texas and Local History Collections. Copies of this publication can be purchased for \$25 by contacting the Rice Historical Society.

President Dorothy Knox Houghton read the Contributions Policy adopted by the Board. (Copy attached to these minutes.) She announced that the Board had approved expending \$4,000 for the retrospective conversion of Texas and Local History Department materials. A letter of explanation from Central Library Chief Brenda Tirrell was read. (Copy attached to these minutes.) In addition, the Friends funded the \$125 purchase of a tape player that will enable patrons to hear oral history tapes made at HMRC in the 1970s. Jim Fisher was thanked for securing this piece of equipment from eBay for us.

A membership brochure is currently being prepared by Nancy Burch and a mailing will be sent when it is completed. We currently have 187 members. Vernon Gillette reported that the Friends' Web site is being reviewed by the library administration and will be put in operation as part of the Houston Public Library Web site when this review is completed. Mr. Gillette suggested that at some future date we may want to consider the feasibility of having our separate site.

Following this business session, George Werner presented an enlightening program on "The History of Texas Railroads."

At the conclusion of his presentation, Mr. Werner, Chairman of the Nominating Committee, reported that the following persons had been nominated to serve as officers of Friends of the Texas Room for 2005-2006:

President – Dorothy Knox Houghton Vice President – Barrie Scardino Secretary – Betty Chapman Treasurer – George Werner Directors – Paul Homeyer, Sims McCutchan, Anne Sloan, and Carol Weaver

There being no further nominations from the floor, Gus Mistrot moved that these nominees be accepted by acclamation; Vernon Gillette seconded the motion, which was approved by voice vote. George Werner thanked those retiring from the Board: Marks Hinton, Jim Glass, Marvin Rich, and Elizabeth Whitlow. Vernon Gillette requested that the body extend their appreciation to these persons by acclamation.

There being no further business, the meeting adjourned at 11:30 a.m.

#### MINUTES FRIENDS OF THE TEXAS ROOM FEBRUARY 1, 2005

Friends of the Texas Room met on February 1, 2005, at 7:00 p.m. at the Museum of Printing History, 1324 W. Clay. President Dorothy Knox Houghton called the meeting to order. Since the minutes of the previous meeting were not circulated to the membership in a newsletter, the approval of those minutes will be postponed until our meeting in April. The president thanked retiring board members Marks Hinton, Jim Glass, Marvin Rich, and Elizabeth Whitlow for their service during the past two years and introduced Carol Weaver, Sims McCutchan, Barrie Scardino, and Paul Homeyer as new board members. She also thanked Betsy Griffin, Director of the Museum of Printing History, for scheduling our meetings for us.

The president reported on the resignation of Barbara Gubbin as director of Houston Public Library and of Rolando Romo as manager of the Houston Metropolitan Research Center. She announced that the Julia Ideson Building Renovation Committee is considering a plan that would construct a new wing that was actually included in the building's 1925 architectural design. This wing would be dedicated entirely to HMRC activities. The first floor of the Ideson building would then be available for public events. Barry Whitehead of Prozign Architects, lead firm for the project, will speak at our April meeting. The president also reported that the HMRC staff is being enlarged; three archivist positions will soon be filled and openings for two new positions, one in the Texas Room and one in Support Services, will be posted on February 2. Betty Chapman announced that the concluding event for the library's centennial celebration will be held on Saturday, February 5, at 11:00 a.m., when a historical marker will be dedicated. She also announced that copies of *100 Years – 100 Stories*, the centennial history, would be available for purchase after the meeting.

The president reported that the board held an all-day planning retreat on January 29. Plans made include revising our by-laws; establishing a Program Committee to plan special events, such as a symposium with a call for papers; forming a Communications Committee to include the newsletter, a web-site, and general publicity; and conducting a membership campaign through a mailing and by having our members speak before other groups in the city. We will expand all of our committees to include more members.

Virginia Hancock reported on the status of the old Cage Elementary School and plans for its renovation. She also shared research that she has been doing on her eastside neighborhood and its early residents, including the Simms family.

Treasurer George Werner reported that our bank balance is \$16,370.32. This amount includes \$4,000, which will be used in the conversion of collection maps to the online catalogue when the library has prepared the materials for this process. The treasurer also reported that \$2,500 was received last year from ExxonMobil in recognition of volunteer hours given at the library by ExxonMobil retirees Dorothy Johnson and George Werner. The president encouraged any other members who might be in a similar position to act accordingly in requesting funds for the Friends organization.

The president introduced Dr. Joseph Pratt of the University of Houston who spoke on the various projects of the Center for Public History at the university. Dr. Pratt expressed his hope that all the historical organizations in the city will come together in a collaborative effort to promote Houston's history. Members were also introduced to the *Houston Review* and encouraged to subscribe to the publication.

There being no further business, the meeting was adjourned at 8:15 p.m.

# NEW ARCHIVISTS IN THE HMRC

**Ronald Dreese (Archivist I):** B.S., Case Western Reserve; M.L.A., University of St. Thomas; M.S.I.S., University of Texas at Austin with focus on archives and records management. Ron did applied coursework at the Texas Military Forces Museum in Austin and an internship as associate librarian for archives and serials at the Noble Foundation in Ardmore, Pennsylvania. He has also worked as a volunteer at the Center for American History at the University of Texas and in the archives section at the University of St. Thomas. He joined the HMRC staff in March.

**Tammy Jordan (Archivist II):** B.A., University of California at Los Angeles; M.L.I.S., San Jose State University. Tammy comes from the Tulare County, California, Public Library, where she was manager of the Annie R. Mitchell History Room. Previously, she served as archivist, special collections librarian, and reference librarian. She also worked as archives assistant for Disney Feature Animation Research. She had additional academic and public library experience prior to earning her M.L.I.S. She joined the HMRC staff in April.

#### **IN MEMORIAM – ANN QUIN WILSON**

FTR Charter Member Ann Quin Wilson died on March 23, 2005. A trailblazer in conducting local research, Ann began documenting Houston's history four decades ago. Her book, *Native Houstonian: A Collective Portrait,* published in 1983, contains photographs and descriptions of the people and places that established the city's foundation. Preserving Ann's book in the HMRC's collection will preserve her love of Houston.
