DR. RHEA BROWN LAWSON NAMED NEW DIRECTOR OF THE HOUSTON PUBLIC LIBRARY

Houston City Council voted to confirm Dr. Rhea Brown Lawson as the Director of the Houston Public Library. In the 101 year history of the library, she will be the sixth director. She comes to Houston from the Detroit Public Library where she served as deputy director.

Dr. Lawson holds a BA in political science from Morgan State University in Baltimore, an MA degree in library and information science from the University of Maryland-College Park, and a PhD in Library and Information Studies from the University of Wisconsin-Madison.

MINUTES OF THE TEXAS ROOM: OCTOBER 15, 2005

Friends of the Texas Room met Saturday, October 25, 2005, at 10:15 a.m. at the Harris County Archives in the Criminal Justice Center, 1201 Franklin. Treasurer George Werner acting for President Dorothy Knox Houghton called the meeting to order, after which the minutes of the July 18, 2005, meeting were approved as printed in *The Texas Room Dispatch*.

Treasurer George Werner reported that we have a balance of \$18,666.68. The video project on the Houston Metropolitan Research Center is underway. Some payments have been made for the conservation of the Wood maps, and we are waiting finalization of the map index.

Brenda Tirrell reported that the Library has a new director, Dr. Rhea Brown Lawson. Her experience as deputy director of the Detroit Public Library and former chief of the Central Library in Brooklyn will benefit Houston's large library system.

Sarah Canby Jackson, the Archivist of the Harris County Archives, had prepared an exhibit of various documents in the collection. She presented a slide program about what it takes to start an archive. She was hired in November, 2002 with no physical location and no budget. Today the Harris County Archives occupies 20,000 square feet on two floors of the Criminal Justice Center and is the only county archives in the state of Texas. Materials have been organized by Sarah with the help of a recently hired second archivist, about 50 volunteers, community service people, and, for the heavy lifting, county inmates.

The meeting adjourned at 11:10 a.m. for the participants to examine the stacks.
